TEMPORARY ORDER
(Section 134)

WHEREAS on March 5, 2021, the Director of Enforcement of the Nova Scotia Securities Commission (the Commission) filed with the Commission a Notice (*Ex Parte* Application) for a temporary order in respect of the Respondents;

AND WHEREAS the Respondents Jessica Lynn GhaneY (aka Jessica Lynn Chaney) and Anthony Carlo Sartor are individuals and officers and directors of the Respondent ForexTips101 Ltd. (a.k.a. or carrying on business as Funding Talent), an extra-provincial corporation with a registered office on Upper Water Street in Halifax, Nova Scotia;

AND WHEREAS the Respondents appear to have conducted trades in securities and/or derivatives in Nova Scotia without being registered to do so and in the absence of an applicable exemption;

AND WHEREAS the Respondents appear to have distributed securities and/or derivatives without filing a prospectus and in the absence of an applicable exemption;

AND WHEREAS the Commission is of the opinion that the length of time required to conclude a hearing could be prejudicial to the public interest;

AND WHEREAS the Commission is of the opinion that it is necessary and in the public interest to make this order;

AND UPON reviewing the Affidavit of Lianne Bradshaw, Senior Investigator with the Commission, sworn March 5, 2021;

IT IS HEREBY ORDERED THAT:

1. pursuant to section 134(1)(a)(i) of the Act, the Respondents shall comply with and cease contravening Nova Scotia securities laws;
2. pursuant to section 134(1)(b)(ii) of the Act, the Respondents shall cease trading in all classes of securities and derivatives, directly or indirectly, except the Respondents Jessica Ghaney (aka Jessica Chaney) and Anthony Carlo Sartor may each trade on their own behalf through a registrant of the securities regulatory authority in the jurisdiction in which they reside;
3. pursuant to section 134(1)(c) of the Act, any exemptions contained in Nova Scotia securities laws cease to apply to the Respondents;
4. pursuant to section 134(1)(e)(i) of the Act, the Respondents shall cease disseminating to the public, or authorizing the dissemination to the public, any information or material that pertains to the trading of securities or to the trading of derivatives;
5. pursuant to section 134(1)(g) of the Act, each of the individual Respondents is prohibited from becoming or acting as a registrant or promoter; and
6. pursuant to section 134(2) of the Act, this Order shall have effect for a period of fifteen (15) days after the date of this Order unless otherwise ordered by the Commission.
